As a company, we may share your personal data, within the scope of our Cookie Policy and limited to the purposes stated above, with third parties benefiting from our company's services, our subsidiaries, business partners, and suppliers, in accordance with the legislation. We would like to inform you that the parties to whom the data is transferred may store your personal data on servers located anywhere in the world.

Cookie Type	Description
Mandatory Cookies	These anonymous cookies enable visitors to browse www.mantagas.com and access secure areas using their features. The information collected by these cookies cannot be used for marketing purposes. If these cookies are not allowed, various parts of www.mantagas.com cannot be used.
Performance Cookies	These anonymous cookies help our Company to improve its website. These types of cookies are anonymous cookies that help visitors to improve our Company's website. Such cookies are used to collect information about how visitors use www.mantagas.com , the most visited pages, whether the Site is working properly, or to detect errors received.

the relevant legislation to third parties with whom your personal data are shared,

- To object to the emergence of a result by analysing your processed personal data exclusively through automated systems,
- In case we suffer damage due to unlawful processing of your personal data, to demand the compensation of the damage.

You may submit your requests regarding your rights under Article 11 of the Law No. 6698 regulating the "Rights of the Relevant Person" and the application of the law to our address crewing@mantagas.com in writing or by using the registered electronic mail (KEP) address or the electronic mail address you have previously notified to our website and registered in our system or in accordance with other application procedures stipulated in the [Communiqué on the Procedures and Principles of Application to the Data Controller](#). We will finalise your request free of charge as soon as possible and within 30 (thirty) days at the latest - up to ten pages - depending on its nature.
